# **UGBOROUGH PARISH COUNCIL MEETING**

Wednesday 2<sup>nd</sup> December 2015 at 7.00pm Committee Room, Ugborough Village Hall

**Questions from the Public** Overhanging vegetation below Beacon View had not been cleared, which the Clerk would follow up; the Clerk would report a pothole on the ridge road and provide Councillors with the DCC online reporting link; fly-grazing had been noted in below the playground in Bittaford.

**District Cllr Holway** reported that SHDC was working with adjoining authorities to meet its commitments, including housing need, and would be considering devolution proposals; budget setting had started and would be determined on the 11 February; a new planning IT system was being introduced; the deadline for TAP applications was the 18 December; £1300 locality funding was available in the Parish, and an application was invited from the Drama Group; and the traveller site at Roborough would proceed, which may have implications for the travellers at Hillhead.

County Cllr Hosking reported that confirmation was needed of the missing junction sign at the eastern approach to Ugborough; Locality and Invest in Devon funding was available, amounting to £2000 per Parish, and a grant towards repairs to the side path at Ugborough Village Hall was suggested.

Feedback was due by 14th December, which would be considered by the working group at a meeting on 14 December. The Working Group would finalise the draft and all the associated documents, to submit to Ugborough Parish Council on 22nd December for consideration at the January 2016 Parish Council meeting. It was intended to issue the draft Ugborough plan for consultation in early 2016, with a referendum in June 2016.

Community Spirit Partnership would charge 2-4 days to review the Plan at a daily charge of £350.

13. Brandon Lewis MP, Minister of State for Housing & Planning: Consultation on Prior Notification applications. The need for Prior Approval for permitted development rights provided a safeguard, as it enabled planning authorities to consider design, location and suitability of the agricultural building for conversion, although sustainability of location was not a consideration as it was recognised many agricultural buildings were not in village settlements. A review would be undertaken on how the permitted development rights in rural areas could be improved, and Ugborough Parish Council would be given the opportunity to express its views in the Call for Evidence.

#### 15.133 Correspondence received

1. SHDC: Community Governance Review. It was proposed to transfer the area East of Ivybridge from Ugborough Parish to Ivybridge Parish. The consultation would run to 24.2.16, and details would be included in the Newsletter.

#### 15.134 TAP schemes

1. Community Lengthsman – A meeting had been held with Nick Colton, DCC Highways, who would provide a schedule of the work to be undertaken. To provide a central crossing in Wrangaton would cost £9000 and £12000 in Bittaford. Cllr Hosking was investigating the extension of the 30mph speed limit beyond Skew Bridge, and advised that it was intended to combine Traffic Regulation Orders to reduce costs. Clarification was requested on the use of farm vehicles, with red diesel, to clear debris from roads.

Resolved to purchase magnetic vehicle strips, vehicle flashing light and gulley pot cover lifter 2. TAP submission 2016: Resolved to submit a £9000 application for mobile traffic calming lights, in conjunction with Ermington, Cornwood and Yealmpton Parish Councils

# 15.136 Reports on Meetings attended

- 1. Clerk: Budgets & Precepts. Negotiations were progressing for Parish Councils to receive 1% business rates; it was proposed to charge business rates on public toilets; the precept demand deadline was the 31 March; and it was suggested that surplus funds at the end of the financial year be placed in a General Contingency Reserve
- 2. Cllr Nelson attended the DNP Forum. The Government's model for National Park funding was for a small core grant, supplemented by income from fees, charges, sales and donations, which the DNP was exploring with other National Park authorities. Pre application advice was available by email, and 88% of applications were determined within 8 weeks, with 89% being approved.
- 3. Cllrs Beable & Holway attended the Community Resilience Forum. The need for more Special Constables was identified; insurance to cover all volunteers cost £35pa; a ten figure map reference was needed for all bridges and strategic points, with laminated information sheets at strategic sites; a link was requested from the Parish Council website to dcisprepared.org.uk; and funding was available for Emergency Plan preparation.
