

UGBOROUGH PARISH COUNCIL MEETING
Ugborough Village Hall
Wednesday 13th March 2019 at 7.30pm
Questions from the Public

- A complaint was received that brown bins were not being returned to properties following collection
- Inconsiderate parking on the pavement in Fore Street, Ugborough was blocking pedestrian access, and would be highlighted in the Newsletter
- The enforcement team had been advised of unauthorised tyre storage and an Airbnb cabin along Yellowberries Lane

DNP C Pannell reported that responses to the National Park Plan were being assessed, with the Plan due to be adopted in 2020. A meeting with DNPA Dan Janota would be arranged to discuss Wrangaton settlement, with C Pannell, Cllrs Beable, Holway & Fletcher attending.

SHDC Cllr Hosking reported the:

- DCC & SHDC Locality funding towards Ugborough Village Hall repairs
- Flood prevention works, which would proceed at Parsonage Lodge, with DCC assisting.
- Flood prevention works at Lutterburn, which were ongoing, pending a planning application. A meeting with DCC John Galt would be requested once the scheme was prepared
- LED street lights had reduced running costs by £850k over 5 years.

DCC Cllr Holway reported:

- A £190k capital programme to replace play equipment
- The budget and council tax had been agreed, with a £5 increase per household in the SHDC share of council tax
- No increase in car parking charges
- A 4-banded council tax reduction scheme for those on low incomes
- The South Devon and River Tamar AONB management plan had been adopted
- Sophie Hosking had been appointed chief executive
- Locality funding of £1200 had been granted to the preschool for preliminary work on a planning application; and £300 to the History Group for an interpretation board for the community herb garden, and for repairs to the Donkey Lane tap.
- S106 funds were available for recreation facilities in Ugborough, and a review of the Open Space Sport & Recreation Strategy would be included on the April agenda

2. Phone box, Wrangaton – The Parish Council had been awarded £1928 towards the £2400 cost of installing a defibrillator
3. Bittaford playground – No report
4. Bittaford & Ugborough public toilets – The Clerk would request a quotation from Howard & Over Solicitors in relation to the Transfer. A Task Force of Cllrs Hosking & Hutcheon would assess the condition of the toilet buildings.
5. The new benches were now in place

19.032 Highways & Rights of Way

1. Cllr Holway had queried the line of the bridleway through Filham Park, which would appear to go through the lake
2. Modbury Parish Council had requested support for repairs to the road to Sheephams from the A131 at Strode Cross to Crownhill Cross, and to request signage that it was unsuitable to HGVs. Cllr Hosking responded that some drainage work had been undertaken and repairs would be addressed when they arose. No funding was available for HGV signage. Similar drainage problems had arisen at Workhouse Brook, and Cllr Beable would ask the community lengthsman to monitor it regularly.
3. Cllrs Beable & Hosking and local residents met DCC Highways Nick Colton to discuss parking at Green Lane, Wrangaton. Discussions included the loss of parking spaces; the need for resident parking spaces; the need to extend the double yellow lines; and the need to redirect the cycle route from Shute Lane to the safer Green Lane. It was suggested that the double yellow lines should be extended and

parking on the Green Lane splay would improve visibility. Cllr Hosking and Nick Colton would draw up plans.

19.033 Travellers at Hillhead Likely changes to the law would make the setting up of encampments a criminal offence.
