

UGBOROUGH PARISH COUNCIL MEETING
Ugborough Village Hall
Wednesday 3rd April 2019 at 7.30pm

Questions from the Public Inconsiderate parking continued on the pavement in Fore Street, Ugborough and opposite the Horse & Groom, Bittaford, which the Clerk would report to the police.

DCC Cllr Holway reported that:

- The capital investment strategy, in which SHDC would borrow up to £60m for acquisitions and schemes within the South Hams, for example, a development in Ivybridge which may include a supermarket, the acquisition of 10 acres at Sherford, and £8m to encourage affordable homes through Community Trusts etc. The aim was to make a small surplus.
- The Joint Local Plan had been adopted. It was noted that Wrangaton was not identified as a settlement, despite the recent planning approval and application for housing development.
- SHDC was joining the Devon Audit Partnership
- Three more Neighbourhood Plans had been adopted, and a new website provided a Neighbourhood Plan portal
- The new waste service procurement had been signed with FCC. Recycling tubs would be introduced. Recycled plastics should be washed and black plastic should be excluded.
- SHDC had received a Bronze Award for hot desking and home working.

SHDC Cllr Hosking reported that:

- He had met with Wrangaton residents concerning parking at Green Lane, following a petition of 17 objectors which he had received at the Annual Parish Meeting. The double yellow lines may be replaced with hatched areas. The National Cycle Network along the B3213 & Shute Lane would be extinguished, but would continue along Wrangaton Road.
- Cllrs Hosking, Hutcheon & the Clerk would inspect the public toilets on the 11 April.
- He was awaiting a response from John Galt over a meeting to discuss the Lutterburn flood prevention works
- White lines in Bittaford would be refreshed, and had been placed on the list
- A speed counter would be placed in Fore Street
- The standing order for clearing the Lutterburn silt trap had been missed last year, but had been requested for the next year.

1. Cllr Hosking attended a meeting of the PL21 Active Travel Group, which aimed for cycle & pedestrian routes to Ivybridge school and town centre from South Brent and Lee Mill. Sustrans would be commissioned to identify secure sites for bike storage, which Cllr Hosking supported.
2. Cllrs Beable, Fletcher & Holway met with DNPA Dan Janota about identifying Wrangaton as a settlement in the Local Plan Review. If, in 2019, the new development at Sidings Cross provided a shop, then the status of Wrangaton may be reviewed in the Local Plan.
